

THE UNIVERSITY WEST END CLUB.

In November, 1898, several members of the University faculty living in the western part of the city held an informal meeting to discuss the possibility of organizing themselves into a club for the general purpose of mutual acquaintance and social intercourse. Complete organization was effected on November 17th, and a constitution was adopted. The presidents of the club have been: Walter M. Smith, 1898–1899; H. L. Russell, 1899–1900; E. B. Skinner, 1900–01; O. G. Libby, 1901–02.

The club began with a membership of about fifty, but in the four years of its growth it has nearly doubled its list of members. The original purpose of the club to limit its membership to a definite part of the city has been gradually given up. The matter now rests largely with the executive committee to determine how inclusive the membership is to become. The papers presented to the club have been uniformly excellent, and in range and variety well represent the diversity of interest among its members. The desired social feature of the club has been secured by having the meetings at the homes of the members. The success in past years has shown the need of such an organization as the University West End Club, and seems to indicate that in the future the club will continue to be what it is now, a center of intellectual and social activity for all its members.

CONSTITUTION.

ARTICLE I. NAME AND OBJECT.

SECTION I. This association shall be called the University West End Club, and its objects shall be the presentation and discussion of papers upon topics of general interest and the promotion of social intercourse.

ARTICLE II. OFFICERS.

SECTION 1. The officers shall be a president, a vice-president and a secretary-treasurer.

SEC. II. The officers shall be elected by ballot at the regular November meeting of each academic year. They shall assume their duties at the time of their election and shall hold office until their successors are duly elected. Vacancies may be filled at any regular meeting.

SEC. III. The duties of the officers shall be such as usually devolve upon officers of similar organizations.

SEC. IV. Immediately upon the election of new members, the secretary-treasurer shall notify them of their election. No person shall be considered a member who shall not have signified to the secretary-treasurer his acceptance of membership in the club.

SEC. v. The secretary-treasurer shall send notice of annual dues to each member immediately after the regular election of officers. Notice of delinquent dues shall be sent four months after the first notice.

ARTICLE III. GOVERNMENT.

SECTION I. The government of the club shall be vested in an executive committee consisting of the officers of the club and two other members to be elected at the same time and in the same manner as the officers.

SEC. II. It shall be the duty of the executive committee to arrange the programs, to provide for the place of meeting and to perform such other duties as may be necessary.

ARTICLE IV. MEMBERSHIP.

SECTION I. Proposals for membership may be made by any member of the club to the executive committee. All persons who are recommended for membership by the executive committee, and who receive a majority of the votes of the members present at any regular meeting, shall be considered members of the club.

ARTICLE V. AMENDMENTS.

SECTION I. Amendments to this constitution may be proposed at any regular meeting. Such amendments shall be submitted in writing and shall lie upon the table until the next regular meeting; for adoption they shall require a majority vote of the members of the club.

BY-LAWS.

1. The regular meetings of the club shall be held on the fourth Friday of each month from October to May inclusive.

2. Special meetings may be called at any time by the executive committee upon the request of eight members.

3. One-third of the members shall constitute a quorum.

4. All membership fees and taxes shall be recommended by the executive committee to be fixed by vote of the club at any regular meeting.

5. The executive committee shall report not later than the January meeting an outline program for the entire year.

6. Any member who fails to pay the annual dues after having received the delinquent notice may be dropped from the list of members at the discretion of the executive committee.
