In the interest of a more comprehensive planning, development, and direction of the Research Work of the University, and both to insure the utmost freedom of research to its scholars and to provide a comprehensive record of all research work done within the University and the sources of its support, the Regents provide that:

All offered gifts for research at the University of Wisconsin, regardless of their source or purpose, shall first be submitted for consideration to an appropriate section of an All-University Research Council to be created, that shall be made up of a Social Science Research Council, a Natural Science Research Council, and such other constituent Councils as may be created, of which Councils the President of the University shall be ex officio chairman.

It shall be the duty of these councils to consider each gift in terms of the scientific needs of the University and the social needs of the public, and to make appropriate recommendation to the Regents respecting the acceptance or rejection of such gift and the manner of administering it that shall best facilitate the research project in question.

In conformity with the increase in fees of the summer school, as approved by the Regents at the meeting held on December 4, 1929, the following schedule of fees for the summer session, as prepared by Director Goodnight, was recommended:

I. For Undergraduates and Graduates in all Colleges and Schools, except the Graduate School, the basic rate is \$4.50 per week plus special fees of \$2 for the Infirmary and \$1.50 for the Union.

Pre and Post Session Fees

Undergraduate: \$4.50 per week. If registrant was not in Summer Session, \$8 for first week and \$4.50 for each succeeding week.

Graduate: \$5 per week. If registrant was not in Summer Session, \$8.50 for first week, and \$5 for each succeeding week.

FEES FOR RESEARCH STUDENTS NOT EARNING CREDIT

Graduate students engaged in independent research and not earning credit in any form shall register in the Summer Session, paying a fee of \$5 plus laboratory or library fees as their work may necessitate.

Graduate students pursuing no courses but who are candidates for an oral examination during the session, may register after the third week of the session for a fee of \$10, but may earn no credit.

Upon motion of Regent Butler, seconded by Regent Sholts, this recommendation was adopted.
