- 13. That \$3,000 be transferred from savings in the salary account, College of Engineering, 20.41 (1)(a) Operation to Regents Unassigned. Adopted.
- 14. That \$250 be made available for extra help, Registrar's Office, chargeable to 20.41(1)(a) Regents' Unassigned. Adopted.
- 15. That a refund of \$74 be made to Charles A. Getz for tuition and incidental fees paid for the second semester, 1926-27, as Mr. Getz has been unable to attend classes, due to illness. Adopted.
- 16. That the date for the assignment of rooms in the men's and women's dermitories to out-of-state students be changed from September 1 to May 15. Adopted.
- 17. That authority be requested from the Emergency Board for the purchase of a Ford one-ton truck for the Animal Husbandry Department, estimated cost \$559, \$359 chargeable to 20.41(1)(d) and \$200 to 20.39 (8)(b) Gifts, Wisconsin Manufacturers' Association.

18. That upon the recommendation of Dean Russell, the following employees of the University be appointed Deputy Sheriffs in connection with the establishment of the University Bay Wild Life Refuge, and that the Business Manager be authorized to execute a bond of \$1,000 for each of these employees as required by law:

The Business Manager was authorized to provide space for the Laboratory for the Dairy and Food Commission in the addition to the Chemistry Building, and to make arrangements with them with reference to occupancy.

A communication was presented from the Trustees of the William F. Vilas Estate regarding the leasing of the Pioneer Block for a period of ninety-nine years.

Action deferred pending investigations of conditions of

the former lease.

The Business Manager presented the request of the Cardinal Putlishing Company for the use of space in Langdon Hall. It was VOTED, That the Business Manager be requested to carry the negotiations further and it was recommended that the Board leave the matter in the hands of the Executive Committee with power to act.

The Business Manager presented a request from the Men's Dormitory Association for the construction of doors on the north sides of Tripp and Adams Halls.

No action taken.

The Business Manager presented a request for reimbursement to Frank Nelson and Wilfred Pierre, residents of Adams Hall, for articles stolen from their rocms.

The request was denied.

The Business Manager presented an offer of the Isom heirs for the sale of thirty acres of land adjoining University Farm.

The communication was ordered placed on file.
