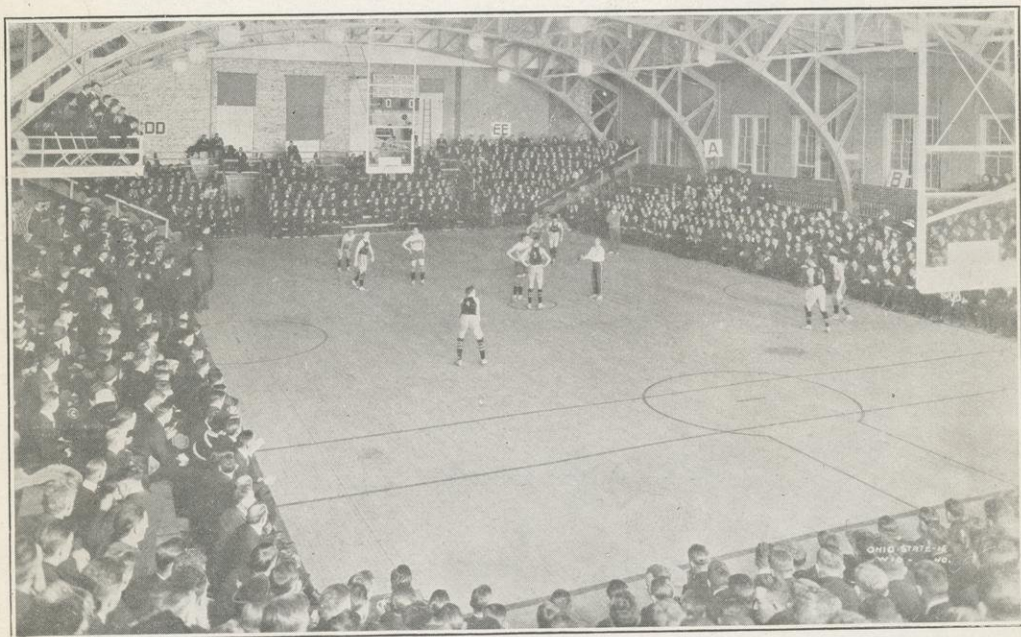

BASKETBALL INTERPRETATIONS

Home team responsible for conduct of spectators

The referee shall call fouls on the home team for unsportsmanlike conduct on the part of the home audience. This includes objecting to the decisions of the officials or addressing remarks to them or to the visiting players.

New Rule—A player may be removed from play and then returned once—providing he has not had four personal fouls called on him.

New Rule—A held ball within the free-throw lane shall be thrown up between two players on the free-throw line.

Free Throwing

In making a free throw the player is entitled to ten seconds for the throw after taking his position on the free-throw line. Any attempt by the spectators or by the opposing players to disconcert in any manner the player making the throw will result in a second trial being given to the player in case the basket is not made. The referee may continue to give the thrower additional trials in case the disturbance continues.

The Dribble

A player may dribble in any direction, in any way, and as long as he pleases until the ball comes to a rest, however slight, in one hand or is touched by both hands simultaneously when the dribble must stop and the ball must be passed or shot. The motion of the ball due to the bouncing or batting must be continuous. The player in starting the dribble may step one foot in any direction, but the rear or pivot foot must not leave the floor until the ball has left his hands. Standing still and bounding the ball constitutes a dribble. Accord-

ing to the new rules this year, a player who muffs or fumbles the ball can not start a dribble after recovering the ball, but must pass or shoot. A shot for goal is permitted at the end of a dribble.

Jump Ball

On a so-called "Jump Ball," as when thrown up at center, or after a held ball, the jumpers must keep one hand behind the back and at the waist line until the ball is touched. On a jump-ball the ball must be tapped by either one or both players otherwise the ball is not in play and must be jumped again. Either jumper may catch the ball after it has been tapped which makes every man eligible to receive the ball after it has been tipped off.

Holding

Holding is personal contact with an opponent which in any way interferes with his freedom of movement. Usually called when a player hooks an opponent with bent arm or grasps the opponent or any part of his equipment in such a way as to keep him out of the play or from the ball. The majority of holding fouls, however, are made in guarding. When a player in guarding places both arms around an opponent even though both hands should be on the ball, constitutes a foul. This rule is largely misunderstood by spectators.

Blocking or Guarding

Blocking or charging, as when a player bumps an opponent out of the way, constitutes a foul. A player may not interfere in any way with the progress of an opponent who has not the ball.

Out of Bounds

A ball hitting any edge of the back stop or its supports is out of bounds and goes to the opposing team out of bounds.

Disqualifications

A player is disqualified who has made four personal fouls. Personal fouls are held to include holding, blocking, tripping, charging or pushing, and any unnecessary roughness. A player may also be disqualified for using flagrant roughness on a player who is in the act of shooting a basket. Example, deliberately shoving a man in the back while shooting.

Extra Points

Two free throws are awarded when a player fouls an opponent who is in the act of throwing a basket. If the ball should be in the air and enter the basket the goal will count which will make possible four points on this particular play.

Call of Time

If the ball is in the air when the signal is given declaring time is up, the goal counts if ball enters the basket.

Tie Game

In case the score is tied at the expiration of the second half an additional playing period of five minutes will be called.
