The Select Committee, whose duty it was made to investigate the securities taken for loans from the school and university funds, &c., beg leave to submit the following

## REPORT:

The committee have had so much to do upon other committees, and in the discharge of their duties in the assembly since their appointment, that they have not had time to make such full investigation as would have been desirable.

They have, however, made a correct list of all the loans made up to the commencement of the present political year, the dates, amounts and description of the securities in the mortgages taken for such loans. This list, together with the list of delinquent borrowers from this fund already furnished to the assembly, when published, will furnish the people of this state with much information upon this subject, and will incite inquiry into the character of the securities taken for loans from these funds.

The committee recommend that one thousand copies of these lists, hereby reported, be published in pamphlet form for the use of the members of the present legislature, to be sent to them by the secretary of state.
