REGULAR MEETING OF THE BOARD OF REGENTS
OF THE UNIVERSITY OF WISCONSIN

Madison, Wisconsin

Held in the President's Office

Saturday, February 6, 1954, 10 A.M.

President Werner presiding

PRESENT: Regents Arveson, Gelatt, Jones, Laird, Renk, Rennebohm, Steiger, Werner.

ABSENT: Regents Wanvig and Watson.

Regent Wanvig was absent from the state, and Regent Watson was absent due to illness.

Upon motion of Regent Laird, seconded by Regent Rennebohm, it was
VOTED, That the minutes of the regular meeting of the Board held on January 9, 1954, be approved as sent out to the Regents.

Dean John Guy Fowlkes appeared before the Regents to discuss the work of the School of Education.

Dean Fowlkes stated that it would be completely contrary to the convictions of the staff of the School of Education unless he began his discussion with an expression of appreciation for the support and consideration which the Regents have given the School of Education in recent years. He also added his own personal expression of appreciation for the consideration which he received from this and previous Boards of Regents since he was first appointed a professor of education.

He reported that the first Board of Regents of the University had apparently recognized the preparation of teachers to be a matter of tremendous importance to the state and University. The first Board of Regents had commented on the fact that the University was a "school of the schoolmasters."

Dean Fowlkes showed a chart giving the chronological development of teacher training activities at the University of Wisconsin. The normal professorship was the second professorship established at the University in 1856 and was held by Mr. Barnard, who was subsequently appointed Chancellor of the University. This professorship was discontinued in 1860. Between 1860 and 1884 there was virtually no teacher preparation at the University. In 1884 a Chair of Pedagogy was established and in 1908 the course for teachers was established. In 1914 the Wisconsin High School was opened. In 1919 the School of Education was established within the College of Letters and Science; and in 1930 the School of Education was established as a separate division of the University. The elementary teacher training program was established in 1951.

A chart was shown listing the various departments of the School of Education and the work of the departments was described by the Dean.

Dean Fowlkes explained a chart which analyzed the degrees and University teachers' certificates granted by the School of Education between 1930 and 1947 and between 1947 and 1954. During the twenty-three year period, 224 Ph.D. Degrees in Education had been granted, of which 123 were granted during the last six years. Dean Fowlkes emphasized the large increase in degrees and certificates granted during the latter period as compared with the former period and compared the number of degrees and certificates in education with those in the University as a whole. He explained a chart showing the average number of degrees granted during the period 1930 to 1954 and pointed out the sharp increase in graduate work in the School of Education.

Dean Fowlkes referred to the sharp attacks which in recent years have been levelled at the preparation of teachers. He reported that the School of Education believed that the only basic foundation for teacher preparation is good sound general education. He stated the belief that the professional educators are not qualified to teach content work. The undergraduate work is prepared by professional educators but should be taught by the regular instructional staff. He read a statement commending the work of the School of Education which had been made by a Committee of the American Association of Colleges for Teacher Education in connection with a study evaluating the work of various schools of education.

Dean Fowlkes described, as an example, a member of the staff of the School of Education who also had teaching duties in several other colleges of the University. He also pointed out that a number of staff members of other divisions assist in the work of the School of Education without actually being on the School of Education payroll.

Dean Fowlkes stated that they consider the administration of student personnel a matter of great importance. As much time is spent in the School of Education as any college to determine that the students belong in the particular courses in which they are enrolled. He described the consideration given to cases requiring the dropping of students from the School of Education.

Dean Fowlkes explained a map showing the location of extension classes in education in the state and reported that such work was given in thirty-six community areas.

A chart indicating the support of the School of Education Research Pro-

gram during the period 1930 to 1954 was explained. This chart indicated the amount of funds received through the University Research Committee, from State appropriations, and also from funds for research from private donors. The large increase in funds from the latter source in recent years was noted. A chart was also shown indicating the average number of research projects by periods and the amount of funds available for research in the School of Education.

Dean Fowlkes explained a tabulation comparing evaluations of the work of the School of Education made by a Committee of the American Association of Colleges for Teacher Education and by the staff of the School of Education. In seven of the eight standards of evaluation studied the ratings by the Committee of the Association were equal to or higher than the ratings made by the staff of the School of Education. The rating by the outside group was lower only in the field of the advanced professional program, regarding which the Dean explained there were differences of interpretation.

Dean Fowlkes stated that the School of Education was doing a good job and, with its present staff, would continue to do so.

In reply to a question, Dean Fowlkes stated that there were 264 students enrolled in the elementary teacher training program and that the selection of elementary teacher training students was very gratifying. In answer to a question he indicated that he believed that students were coming to the University of Wisconsin School of Education from areas where other teacher training institutions are operating. He stated that no other institution gives a Ph.D. Degree in Education in Wisconsin. The Wisconsin State Colleges at Superior and Milwaukee give Master's Degrees. He reported that most of the persons with Ph.D. Degrees in Education go on to teach in colleges but that an increasing number were going into the public elementary and secondary school systems largely as school administrators.

RECOMMENDATIONS OF THE PRESIDENT

Upon motion of Regent Steiger, seconded by Regent Rennebohm, it was VOTED, That the gifts and grants listed in EXHIBIT A, attached, be accepted; and that the Vice President of Business and Finance be authorized to sign the agreements.

President Fred made the following statement regarding the gift of one hundred and sixty-five scientific books from the personal library of the late Dr. Sobey Okuyama:

"I would like to call to your attention Item (q) on page 2 of the gifts and grants, the presentation by Brookhill Farms, Inc., of a library of books and journals to the University.

"This gift, which includes one hundred and sixty-five books and important journals in the field of Veterinary Science, Public Health, and allied fields, will enrich our holdings in this area, and will aid both our teaching and research.

"Some of the journals fill out our incomplete sets.

"These publications were gathered, over the years, by Dr. Sobey Okuyama, the Japanese scientist, who joined the Brookhill Farms organization in 1911, and served as its veterinarian until his death last July.

"Doc Sobey, as he was fondly called by all who knew this charming Oriental, worked closely with the University's veterinary scientists and dairy experts for forty years.

"Now, his scientific library comes to the University through his generosity and that of Mr. Howard T. Greene, of Brookhill Farms, Inc."

Upon motion of Regent Jones, seconded by Regent Rennebohm, Actions 1 and 2, listed under the report of the Vice President of Business and Finance (II. Confirming Actions) were approved, ratified and confirmed.

III. Budget Transfers

The Vice President of Business and Finance presented the report of budget transfers for January, 1954, for the information of the Regents. (EXHIBIT C attached)

The Secretary reported that the Regents had considered several items in informal conference on February 5 and had informally approved resolutions to be given formal consideration today.

The Regents in informal conference on February 5 had considered the request of the Midwest Shrine Association for the use of the field house and stadium for the convention of the Association in 1956. The Secretary reported that the regulations previously adopted by the Regents governing the use of University facilities did not provide for the use of such facilities by such non-University organizations as the Midwest Shrine Association for events that are not sponsored by a department of the University, and that, if this request were approved, it would have to be as an exception to the existing regulations. Upon motion of Regent

Steiger, seconded by Regent Renk, it was

VOTED, That the request of the Midwest Shrine Association to use the University Field House and Stadium for its convention in 1956 be approved.

The Secretary reported that the Regents on February 5 in informal conference had given further consideration to their previous action relating to the construction of a new women's dormitory on the site of Chadbourne Hall and to the urgent need for constructing such a dormitory as soon as possible. Regent Rennebohm pointed out that no state funds would be involved for the construction of a proposed women's dormitory on the site of Chadbourne Hall. Upon motion of Regent Jones, seconded by Regent Steiger, it was

VOTED, That, as it is the considered opinion of the Regents that a new dormitory for women should be constructed on the site of Chadbourne Hall, the previous action taken by the Regents in this regard be respectfully reiterated to the State Building Commission with an explanation of the need for the dormitory and of the reasons for its location; and that the approval of the Governor be requested for the immediate employment of architects and for construction of the dormitory on the Chadbourne Hall site.

The Secretary reported that the Regents on February 5 in informal conference had given further consideration to the need for low-cost housing units for both men and women students and to the need for providing University housing for married students. Upon motion of Regent Laird, seconded by Regent Renk, it was

VOTED, That the administrative officers of the University be directed to discuss with the State Building Commission the following matters relating to student housing:

1. The construction and financing of a low-cost housing unit for women on the site of the present Babcock House on the west side of North Lake Street.
2. The construction and financing of a low-cost housing unit for men in a suitable location.
3. The construction and financing of housing for married students in suitable locations.

Regent Renk presented the report of the Educational Committee.

Upon motion of Regent Renk, seconded by Regent Laird, it was

VOTED, That the following recommendations of the Educational Committee be adopted:

(Cont.)

1. That the resignation of Francis Shoemaker, associate professor of education, School of Education and Wisconsin High School, be accepted to take effect January 15, 1954.
2. That the appointment of Friedrich Wilhelm Karl Franz Treue as Carl Schurz Visiting Professor of history, for the second semester of 1953-54, be cancelled.
3. That Harold F. Deutsch, associate professor of physiological chemistry, be granted leave of absence, without pay, from February 1, 1954 to September 1, 1954.
4. That Chester V. Easum, professor of history, be changed from research leave, Graduate School, to leave of absence, without pay, for the second semester of 1953-54, College of Letters and Science.
5. That the appointment of Eugene N. Cameron, professor of geology, be reduced from full time to half time for the second semester of 1953-54; and that his salary be reduced accordingly from \$3,900 to \$1,950 for the semester; credit L. & S., Geology.
6. That the leave of absence granted Joseph O. Hirschfelder, professor of chemistry, October 24, 1953, be amended to include \$334.16 additional salary while on leave; chargeable to Army contract 16D-682. Authorization from the Army for the payment of this salary was received subsequent to the Regent action of October 24, 1953.
7. That Frederick J. Hoffman, professor of English, on leave, without pay, for the second semester of 1953-54, be given a Graduate School appointment for the semester; salary \$750 for the semester; charge to 53:17, 1A-1B, to supplement a Fulbright grant.

Upon motion of Regent Renk, seconded by Regent Arveson, it was

requirements for the Bachelor of Laws (LL.B.) degree and for the Master of Laws
(LL.M.) degree be approved:

- (1) That the requirements for graduation from the Law School be modified, effective as to ~~the class~~ students entering in the ~~fall of~~
1940 summer of 1954 and thereafter, so as to require (1) the completion of courses totalling at least ~~80~~ 90 credits with a weighted average of 77, together with the present residence and apprenticeship requirements; and (2) in the case of those electing not to serve an apprenticeship, the completion of at least ~~88~~ 100 credits with a weighted average of 77, together with the existing requirements regarding residence and the practice courses.

- (2) Requirements for the Master of Laws (LL.M.) degree.

(a) Admission to candidacy:

Candidates shall have completed the requirements for a Certificate of Law from the University of Wisconsin Law School or the equivalent thereof from another law school having comparable requirements and shall be approved by the Dean of the Law School.

(b) Awarding of the degree:

Candidates shall satisfactorily complete an approved program of study and research and spend one academic year in residence.

- (3) These requirements shall be effective immediately except for persons presently candidates for the Master of Laws (LL.M.) degree under the requirements of December 3, 1945.

Regent Jones presented the report of the Business and Finance Committee.

Upon motion of Regent Jones, seconded by Regent Rennebohm, it was
VOTED, That, upon the recommendation of the University Campus Planning
Commission, the final plans and specifications for the Commerce Unit of the Social
Studies Building be approved; and that authority be granted to advertise for bids.

Regent Jones moved, and Regent Steiger seconded the adoption of the following recommendation of the Business and Finance Committee:

"That, upon the recommendation of the University Campus Planning Commission, approval be given to the preliminary studies which envision uniform floor heights in the new West Wing of Birge Hall, with consequent necessity for ramps or stairs to connect the two portions of the building; the separation of the new wing from the old portion of the building by a stairwell; and the setting of the new wing back of the front line of the present central portion of Birge Hall."

At the request of Regent Jones, Director A. F. Gallistel showed an architect's sketch of Birge Hall and the proposed west wing addition. He explained the various problems regarding the construction of this addition which require preliminary consideration before further work can be done on the preliminary plans and specifications. The lack of operating quarries for Madison sandstone would make the cost of that material excessive for use on the exterior of the proposed addition. The alternative would be to use brick and Minnesota limestone, samples of which were shown. Director Gallistel explained that the varying floor levels in Birge Hall presented a problem in connecting the proposed addition to the present building and resulted in the recommendation that the floor levels in the addition be of uniform height with the addition being connected to the present building by a stairwell, with access to the present building floor levels either by steps or ramps. He also explained that the differences between the present building and the proposed addition, both as to different floor levels and exterior treatment, resulted in the recommendation of the new wing being set back of the front line of the present central portion of Birge Hall. Regent Jones stated that some of the Regents believed that the exterior of the new wing should be entirely of stone instead of brick and stone, if at all possible. Director Gallistel reported that he had received an estimate that the exterior treatment would cost about \$2.00 per square foot of wall space for brick and \$7.00 per square foot for stone. It was pointed out that the question of the exterior treatment would be given further study and that the recommendation under consideration relates only to the preliminary studies which precede the preparation of the preliminary plans and specifications which will subsequently be presented to the Regents for approval.

The question was put and the above recommendation of the Business and Finance Committee relating to the preliminary studies for the new West Wing of Birge Hall was approved.

Regent Jones presented the following recommendation of the Business and Finance Committee:

"That, upon the recommendation of the University Campus Planning Commission, the plan for landscaping the area between the Memorial Library and the State Historical Society Building, as shown in the sketch identified as Plan 5, be approved."

At the request of Regent Jones, Director A. F. Gallistel showed a sketch

(Cont.)

(identified as Plan 5) of the proposed plan of landscaping for the lower campus between the Memorial Library and the State Historical Society Building. He explained that of the various plans submitted this one had been selected for recommendation because it was deemed desirable to provide diagonal walks across the area. He pointed out that the plan called for some trees on State Street and Langdon Street being removed to provide a vista toward Lake Mendota. It was pointed out that the plan provided for a future fountain in the center of the area which could perhaps be financed by gifts. It was reported that no estimates of cost for landscaping the lower campus had been made and that no determination had been made at this time as to the possible source of funds. Upon motion of Regent Jones, seconded by Regent Steiger, it was

VOTED, That, upon the recommendation of the University Campus Planning Commission, the plan for landscaping the area between the Memorial Library and the State Historical Society Building, as shown in the sketch identified as Plan 5, be approved. (Copy of Plan 5 on file.)

Upon motion of Regent Jones, seconded by Regent Rennebohm, it was

VOTED, That, upon the request of Wisconsin Alpha of Sigma Alpha Epsilon, the balance of \$30.00 in the principal account and the balance of \$2.96 in the income account of the Sigma Alpha Epsilon War Memorial Scholarship Fund be refunded to the donors, Wisconsin Alpha of Sigma Alpha Epsilon.

Upon motion of Regent Jones, seconded by Regent Renk, it was

VOTED, That the Vice President of Business and Finance be authorized to sign an agreement between the Regents of the University and Carl Bernard, Madison, for leasing of the boathouse concession at the University Boathouse for the period beginning November 1, 1953, and ending October 31, 1954, on the same terms and conditions as for the 1952-53 season.

Upon motion of Regent Jones, seconded by Regent Steiger, it was
VOTED, That the following resolution be adopted:

RESOLUTION

RESOLVED, that The Regents of The University of Wisconsin utilize the services of Federal Reserve Bank of Chicago for the safekeeping of United States Government securities owned by The Regents of The University of Wisconsin or by any of its agencies or departments, upon terms and conditions prescribed by said bank.

RESOLVED, that such securities deposited for safekeeping with Federal Reserve Bank of Chicago may be released from safekeeping, delivered, sold, redeemed,

RESOLVED, that the Secretary of The Regents of The University of Wisconsin forward a certified copy of this resolution to Federal Reserve Bank of Chicago together with a certificate attesting to the names and signatures of the present incumbents of the offices described above; and that the Secretary of The Regents of The University of Wisconsin further certify to the bank from time to time the signatures of any successors in office of any of the present incumbents.

RESOLUTION

WHEREAS, much of the scenic and scientifically important Wisconsin Dells area, a total of more than 1,000 acres adjoining the Wisconsin River, has been transferred to the Wisconsin Alumni Research Foundation for the benefit of the University of Wisconsin and the people of the State; and

WHEREAS, this area has been preserved through the foresight of Henry Hamilton Bennett, whose early photographs captured the Dells beauty; of his daughter and son-in-law, Mr. and Mrs. George H. Crandall, who acquired and improved much of the property; and of their daughters

and sons-in-law, Mr. and Mrs. H. Howard Musson and Dr. and Mrs. Ralph Connor, who maintained and now have generously transferred the property; and

WHEREAS, The Wisconsin Alumni Research Foundation has indicated its intention to perpetuate and further improve this area as a beauty spot and to dedicate the net income to the University;

THEREFORE, BE IT RESOLVED that The Board of Regents of The University of Wisconsin commend the foresight of those who have preserved this magnificent area, and thank all those who have worked to make its benefits permanently available to the people of Wisconsin.

Upon motion of Regent Gelatt, seconded by Regent Laird, it was VOTED, That the above resolution relating to the transfer of a Wisconsin Dells area to the Wisconsin Alumni Research Foundation be adopted.

Regent Renk read a newspaper article concerning the recent University mid-year graduation convocation. He stated that it was an unfortunate decision to require the graduating students to pay the expenses in connection with their graduation convocation. He felt that the University should resume the former practice of paying such expenses. President Fred pointed out that more than the matter of the expenses was involved in this decision. It was the desire of the University to provide an opportunity for the students to more actively participate in planning and carrying out this mid-year convocation. This resulted in closer and more active support of this convocation and it was better attended than in previous years. President Fred also pointed out that degrees are not awarded at the mid-year convocation and that the mid-year graduates are supposed to attend the commencement exercises in June. He stated that a study is being made as to what is being done at other universities regarding graduation exercises for students completing their University work at mid-year or at the close of summer sessions. Upon motion of Regent Renk, seconded by Regent Laird, it was

VOTED, That, if the University has mid-year or summer session convocations or graduation exercises, the University should finance them.

Regent Gelatt extended an invitation to the Regents on behalf of the La Crosse Branch Experiment Station and himself to hold the July, 1954, Regent meetings in the La Crosse area. Upon motion of Regent Steiger, seconded by Regent Arveson, it was

VOTED, That the invitation of Regent Gelatt to hold the July, 1954, Regent meetings in the La Crosse area be accepted with gratitude.

Upon motion of Regent Renk, seconded by Regent Steiger, it was
VOTED, That the meeting adjourn.
