POSTPONED REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, November 20, 1948, 10 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Gelatt, Grady, Hodgkins, Jones, Kleczka, Sensenbrenner, Werner.

ABSENT: Regent Arveson.

Regent Arveson was present for committee meetings on November 18 and 19.

Upon motion of Regent Hodgkins, seconded by Regent Kleczka, it was VOTED, That the minutes of the special meeting of the Board held on October 28, 1948, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Faculty Actions -

1. That the following Faculty actions be approved:

- (a) Calendar for the academic year 1949-50 and for the 1950 summer session. (EXHIBIT A attached)

Upon motion of Regent Gelatt, seconded by Regent Campbell, recommendation No. 1 (a) listed under Faculty Actions was adopted.

- (b) The following recommendation of the Graduate School regarding the language requirements for the Ph.D. degree:

(Cont.)

A reading knowledge of two foreign languages in which there is substantial scholarly literature in the student's major field is required of all candidates. One of these languages must be French or German. The student must obtain approval of his choice of languages from his major professor, the chairman of his major department, and the Dean of the Graduate School not later than the third semester of graduate work.

The Graduate School Office will supply a card to the student on which he will indicate his choice of the two foreign languages in which he will demonstrate a reading proficiency. The major professor and the chairman of the major department shall certify by their signatures on the card that in the student's field of study and research there is a substantial body of scholarly literature in the foreign languages chosen. The signature of the Dean of the Graduate School will constitute final approval for the two languages shown on the card.

Certification of reading proficiency in these languages must be obtained from the appropriate language departments of the University of Wisconsin upon passage of an examination. Students should pass the foreign language examinations and file the certificates with the Dean of the Graduate School as soon as possible after admission to the Graduate School. These certificates must be filed with the Dean of the Graduate School before the student may be admitted to the preliminary examination.

Upon motion of Regent Werner, seconded by Regent Gelatt, recommendation No. 1 (b) listed under Faculty Actions was adopted.

Upon motion of Regent Kleczka, seconded by Regent Grady, recommendation No. 1 listed under Degrees was adopted.

- Appointments -

1. That upon the nomination of Dr. W. D. Stovall and the recommendation of the Dean of the Medical School, M. Starr Nichols, senior chemist, State Laboratory of Hygiene, professor of sanitary chemistry and lecturer in sanitary engineering, be named assistant director of the State Laboratory of Hygiene, without change in salary; the appointment to take effect immediately.

Upon motion of Regent Campbell, seconded by Regent Werner, recommendation No. 1 listed under Appointments was adopted.

- Gifts and Grants -

1. That the following gifts and grants be accepted; and that the Vice President of Business and Finance be authorized to sign the agreements:

GIFTS

(a) \$1,000.00 - From CIBA Pharmaceutical Products, Inc., Summit, New Jersey, for the continuation of a graduate fellowship in organic chemistry for a ten months period at a time when a suitable candidate is available. *Agreement*

(b) 10.00 - Rabbi Landman, Kew Gardens, New York, to be added to the Medical Library Building Fund of the University of Wisconsin Medical School.

- (c) \$ 25.00 - An anonymous contribution to be added to the Medical Library Building Fund as a memorial to Mrs. William Snow Miller. *Letter with papers.*
- (d) 550.00 - Trustees of Dr. Martha L. Edwards Memorial Scholarship Fund, to be available for the Dr. Martha L. Edwards scholar chosen by the Department of History for the academic year 1948-49.

- (e) That the terms of the gift of \$500 from Orchesis, dance club, accepted by the Regents on December 6, 1941, be amended to read as follows:

Done

"Orchesis, dance club in the Department of Physical Education for Women, for the establishment of a trust fund for the furthering of the interests of dance at Wisconsin. The interest from the fund, and in emergencies not to exceed \$100 of principal in the aggregate, to be awarded to a deserving major in dance or for any justifiable project for furthering the interests of dance, upon the recommendation of the Director of the Department of Physical Education for Women and the members of the dance staff. In the event the principal is partially depleted, interest earned will be added to the principal until a \$500 balance is regained. Temporary withdrawals from the fund to further the interests of the dance program may be repaid to the income account of the fund." *Letter with papers.*

- (f) 100.00 - An increase in the total stipend of The Wisconsin Garden Club Federation scholarship from \$100 to \$200 for 1948-49, all other conditions of the scholarship to remain the same.
- (g) 1,500.00 - John Morse Memorial Foundation, Chicago, Illinois, to be added to the John Morse Memorial Foundation Scholarship Fund, to provide scholarships of \$500 each in the College of Engineering; and that Robert Royce Johnson, Harry Schrage, and Ralph I. Hauser be granted the scholarships for the academic year 1948-49.
- (h) The following gifts were received in connection with the Junior Livestock Exposition held in Madison October 25 to 28, 1948:

Mr. Joseph Rothschild of Barton Brothers, donated the grand champion steer and grand champion fat lamb of the show.

Mr. Robert M. Roy, President, Piggly Wiggly Super Market, donated the reserve champion fat lamb of the show.

In addition to these gifts certain animals purchased at the show have been loaned to the University for a limited time. Oscar Mayer and Company has loaned the grand champion and reserve champion barrows and the fourth prize barrow, and Mr. Louis Hirsig, of Wolff, Kubly & Hirsig, has loaned the reserve champion steer. *Letter from Hirsig with papers.*

(i) \$ 11.00 - From the Friends of the University Library to be used in accordance with the purposes of this organization as stated in the Regent action of December 13, 1947, authorizing the founding of the Friends of the University Library.

(j) 53.96 - To be added to the Wisconsin Idea Theater Fund in accordance with the purposes as stated in the Regent action of August 28, 1948.

(k) 750.00 - C. L. Egbert, Eau Claire; Frank R. Horner, Madison; M. A. Carroll, Oshkosh; Victor M. Stamm, Milwaukee, for the establishment of the Northwestern Mutual, Wisconsin General Agents Scholarships in the School of Commerce, to provide three scholarships of \$250 each to be awarded annually to fully registered students in the School of Commerce in accordance with the conditions of award as approved by the donor and the Dean of the School of Commerce. *See Gift file*

(l) Mr. August Peter, Milwaukee, Wisconsin, a collection of chamber music scores and German books on music; the collection to be accessioned and cataloged in the Mills Memorial Library and to be known as the August Peter Collection. *Letter from Prof. Coon with papers.*

(m) 2,500.00 - University of Wisconsin Foundation, for the support of the A. J. Horlick Fellowship in the History of Pharmacy, during the period September 1, 1948 to August 31, 1949, in the School of Pharmacy. This gift represents the first allotment from the gift of \$25,000.00 by A. J. Horlick, Racine, Wisconsin, to the University of Wisconsin Foundation for the support of work in the field of History of Pharmacy at the University of Wisconsin. *04*

GRANTS

(a) \$5,700.00 - Oscar Mayer & Company, Madison, Wisconsin, for the establishment of industrial fellowships to study the treatment of packing plant wastes during the period November 1, 1948 to October 31, 1949, in the Departments of Civil Engineering and Soils. *Agreement*

- (b) \$2,000.00 - Lakeside Laboratories, Milwaukee, Wisconsin, for the continuation of a fellowship in Medicine in the Medical School. The funds to be used in a "clinical program on organic mercurial Mercuhydrin." *Agreement*
- (c) 3,860.00 - Wildlife Management Institute, Washington, D.C., for the continuation of a research fellowship in the Department of Wildlife Management, for the period, September 1, 1948 to August 31, 1949, to study ringneck pheasant populations in a limited geographic area.
- (d) 500.00 - Abbott Laboratories, North Chicago, Illinois, wishes to make available to the University of Wisconsin, during the period July 1, 1948 to June 30, 1949, additional funds to purchase chemicals, supplies, needed apparatus, and to defray other necessary costs in connection with a five-year research fellowship in the field of nutritional chemistry, Department of Biochemistry. (Original grant of \$5000 accepted April 15, 1944, \$500 additional accepted August 16, 1947.)

Upon motion of Regent Kleczka, seconded by Regent Werner, recommendation No. 1, Gifts (a) to (m), inclusive, and Grants (a) to (d), inclusive, was adopted.

Upon motion of Regent Werner, seconded by Regent Gelatt, it was VOTED, That resignations numbered 1 to 28, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Hodgkins, seconded by Regent Kleczka, it was VOTED, That appointments numbered 1 to 245, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Campbell, seconded by Regent Gelatt, it was VOTED, That salary and service adjustments numbered 1 to 145, inclusive, listed under Actions by the President, be approved.

The above actions by the President taken since the October 16, 1948, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

President Fred reported that at the April 17, 1948, meeting of the Board of Regents, it was voted "That Kenneth Little be appointed Acting Director of Public Service beginning April 7, 1948," and that Mr. Kenneth Little has requested that he be relieved of his duties as Acting Director of Public Service. Upon recommendation of President Fred, and upon motion of Regent Kleczka, seconded by Regent Campbell, it was

VOTED, That Mr. Kenneth Little, Registrar and Director of Student Personnel Services, be relieved of his duties as Acting Director of Public Service and that these duties be assigned to the Vice President of Academic Affairs, effective immediately.

Upon recommendation of President Fred, and upon motion of Regent Hodgkins, seconded by Regent Werner, it was

VOTED, That, in addition to the membership on the Campus Planning Commission approved by the Regents on February 15, 1945, the Vice President of Academic Affairs be made a member of the Campus Planning Commission.

RECOMMENDATIONS AND REPORT OF THE VICE PRESIDENT OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

1. That the Vice President of Business and Finance be authorized to sign Amendment #1 to the Office of Naval Research Contract N7-onr-28503 covering research conducted in the Department of Physics, extending the termination date of the contract to June 14, 1950 and increasing the total estimated cost, to be reimbursed by the Navy, from \$13,579.00 to \$25,812.00.

Adopted.

2. That the Vice President of Business and Finance be authorized to sign contract AT-11-1-GEN-7 between the United States Atomic Energy Commission and The Regents of The University of Wisconsin providing a grant of \$54,166.67 for basic research in nuclear physics during the period June 1, 1948 to June 30, 1950. (This contract replaces the temporary letter contract approved by the Regents on May 28, 1948.)

Adopted.

3. That the Vice President of Business and Finance be authorized to sign Office of Naval Research Contract N7-onr-28504 covering research to be conducted in the Department of Chemistry during the period February 1, 1949 to January 31, 1950, at an estimated cost of \$9,088.00 to be reimbursed by the Navy.

Adopted.

Upon motion of Regent Werner, seconded by Regent Gelatt, recommendations 1 to 3, inclusive, listed under the recommendations and report of the Vice President of Business and Finance (I. Contracts, Leases and Agreements) were adopted.

II. Report of Actions Taken

1. In accordance with the authority granted by the Regents on September 27, 1947, for the Vice President of Business and Finance to sign contracts and leases not in excess of \$2,500.00, the following contracts and orders have been signed:

- (a) Memorandum agreement with the University Club, Madison, Wisconsin, for the rental of office space in the University Club beginning October 11, 1948, at an annual rental of \$1.40 per square foot.

Total Annual Rental \$627.20

- (b) Contract with Trachte Brothers Company, Madison, Wisconsin, for the furnishing and erecting of a prefabricated steel building, to be used for a boathouse for the University crew, on the City of Madison property on the Yahara River.

Total \$2,398.00

- (c) Contract with J. J. DeMelle and Son, Sturgeon Bay, Wisconsin, for the furnishing of labor and material for the installation of a furnace in the Foreman's house at the University Peninsular Branch Experiment Station at Sturgeon Bay, Wisconsin.

Total \$635.00

- (d) Contract with Banks Builders, Sturgeon Bay, Wisconsin, for the installation of rubberoid asphalt shingles on the dairy barn, at the Peninsular Branch Experiment Station, Sturgeon Bay, Wisconsin.

Total \$540.00

- (e) Fred Peterson Trust Estate, Appleton, Wisconsin, for the rental of office space at 108 West College Avenue, Appleton, Wisconsin, at a rental of \$21.50 per month for the period July 1, 1948 to June 30, 1949, for the office of University Extension Field Representative.

Total \$258.00.

Approved.

2. In accordance with authority granted by the Regents for the Vice President of Business and Finance to sign contracts and agreements for educational services requested by the Government, Supplement No. 6 to Veterans Administration Contract VA-vr-357 covering the furnishing of correspondence courses by the University Extension Division has been signed providing for the addition of additional correspondence courses under the contract.

Approved.

Upon motion of Regent Werner, seconded by Regent Gelatt, actions 1 and 2 listed under the recommendations and report of the ^{Vice} President of Business and Finance (II. Report of Actions Taken) were approved.

The Vice President of Business and Finance presented proposed traffic ordinances for the Eagle Heights University Housing Project and the Randall and Monroe Trailer Camps. Regent Werner suggested that the resolution relating to the proposed traffic ordinances be amended to provide that appropriate signs be erected notifying the public of these traffic ordinances. Upon motion of Regent Grady, seconded by Regent Campbell, it was

VOTED, That the following traffic ordinances for the Eagle Heights University Housing Project and the Randall and Monroe Trailer Camps be adopted:

(1) Eagle Heights University Housing Project

- (a) No motor vehicle shall be driven on any road traversing the Eagle Heights University Housing Project at a speed in excess of ten miles per hour.
- (b) East bound traffic leading from the Eagle Heights University Housing Project to University Drive shall come to a full stop at the intersection of University Drive.

(2) Randall and Monroe Trailer Camps

- (a) No motor vehicle shall be driven on any road traversing Randall Park Trailer Camp and Monroe Park Trailer Camp at a speed in excess of ten miles per hour.

- (3) The penalties for violation of the above ordinances shall be the same as in Section 10 of the rules and regulations for the management, administration and regulation of land and property owned by the University of Wisconsin adopted by the Regents of the University of Wisconsin in September, 1942;

and that appropriate signs be erected notifying the public of these traffic ordinances.

Secretary Peterson reported that the Regents of the University and the Board of Regents of Normal Schools on Thursday, November 18, 1948, had discussed the study being made by the Wisconsin Education Association regarding improvements in the Teachers Retirement System and it had been suggested that committees of the two boards be appointed to work with the Wisconsin Education Association on this study. Upon motion of Regent Kleczka, seconded by Regent Grady, it was

VOTED, That the President appoint a committee of three members of the Regents of the University of Wisconsin to work with a committee of the Board of Normal School Regents and a committee of the Wisconsin Education Association to study possible revisions for the improvement of the Teachers Retirement System. (President Sensenbrenner has appointed the following committee - Regents Grady, Kleczka and Gelatt.)

Secretary Peterson reminded the Regents that the Student Board of the University of Wisconsin had invited the Regents to be guests of the Student Board at dinner on December 10, 1948.

Regent Werner presented the report of the Finance Committee. Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the fees for the eight-week summer session be increased from \$50.00 to \$60.00, beginning with the 1949 summer session.

Upon motion of Regent Werner, seconded by Regent Gelatt, it was VOTED, That the following regulations regarding the use of University-owned motor vehicles be adopted:

University-owned motor vehicles are to be used for official University business only.

The use of University-owned motor vehicles to provide transportation between office and private residence, as well as all other personal use of such vehicles, is prohibited. Storage of University-owned motor vehicles on private property is allowed only when approved in advance by the Vice President of Business and Finance.

Persons not engaged in University business travel at their own and the driver's personal risk.

Upon motion of Regent Werner, seconded by Regent Jones, it was VOTED, That a renewal of a lease with the State Department of Public Welfare of Wisconsin for the two-hundred acre farm in Chippewa County, known as the Henneman Farm, for a period of five years from March 16, 1949, at an annual rental of \$1600, payable semi-annually, be approved, and that the President and Secretary be authorized to sign the lease. (This lease carries an option to purchase for the sum of \$26,000.)

Upon motion of Regent Werner, seconded by Regent Jones, it was VOTED, That an additional allotment of \$6100 from the War Contracts Reserve Account for the remodelling of additional offices and classrooms in the Education-Engineering Building and an additional allotment of \$14,000 from the War Contracts Reserve Account for remodelling offices and classrooms for the Office of the Secretary of the Faculty and the Speech Department in Bascom Hall be approved.

Upon motion of Regent Werner, seconded by Regent Grady, it was VOTED, That the Secretary be authorized to sign on behalf of The Regents of the University of Wisconsin the Appearance and Waiver of Service of Citation and Notice in the matter of the Estate of Josephine S. Simpson, deceased.

(Confirming written approval by the Regents.)

Regent Jones presented the report of the Constructional Development Committee. Upon motion of Regent Jones, seconded by Regent Kleczka, it was

VOTED, That the Regents reaffirm their action of January 31, 1948, that the plans and specifications for the Milwaukee Extension Center Addition be completed.

Upon motion of Regent Jones, seconded by Regent Hodgkins, it was

VOTED, That upon the recommendation of the Campus Planning Commission the preliminary plans for seats in the North portion of the Stadium and in the two sections where there are wooden bleachers (Western section) be approved and that the architects be authorized to complete plans and specifications for these portions, and that action be reserved concerning the press box and additional rows of seats for the West side until further information is received.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was

VOTED, That the Vice President of Business and Finance be authorized to sign an extension of the agreement dated January 22, 1948, between The Regents of the University of Wisconsin and Schmidt, Garden and Erikson, Architects, Chicago, Illinois, covering architectural services for additions to and alterations in the Wisconsin General Hospital building, to provide for architectural services for the proposed cancer research hospital addition.

Regent Gelatt made the following statement:

"In August, 1947, the Regents directed the University administration to have made a detailed study of the University's functions and policies. The President subsequently appointed a representative committee of the faculty and administration to make the study.

The committee has made a First Report to the Regents in which data are presented on present facilities for higher education in Wisconsin, enrollment, and estimates of needs for higher education in Wisconsin in relation to predicted enrollments in future years. The report also deals at considerable length with the instructional functions of the University and with the organization of higher education in Wisconsin.

The committee has informed the Regents that it was desirable in the judgment of the committee to study those phases of higher education on which the First Report deals before intensive work was done on a critical internal analysis of the University's functions. The Regents regret the delay in the self analysis of the University's functions and policies and have asked the committee to expedite that phase of its work.

The Regents are not in agreement with the recommendations of the Committee on Functions and Policies, and after careful consideration order, and I move, that the said report of the committee be filed without endorsement or approval."

Upon second by Regent Kleczka, the motion of Regent Gelatt was voted unanimously. President Sensenbrenner reported that Regent Arveson, who was unable

to be present for the meeting, had asked him to state he would have voted "Aye" on the above motion if he had been present. (Copy of the report of the Functions and Policies Committee is on file with the records of this meeting.) *Signed copy of report with papers. Extra copy not signed in 76pt*
