- (a) \$ 8,071.91 - Wisconsin Alumni Association to be added on a temporary basis to the Trust Fund Principal account of the Frank O. Holt Scholarship Fund with the income to be used for cash scholarships awarded from the Frank O. Holt Scholarship Fund. This contribution is to be refunded to the Wisconsin Alumni Association when, in the opinion of the Association, it is needed for other Association purposes, or when other contributions are sufficient to carry on the objectives of the Frank O. Holt Scholarship Fund.
(Trust Fund)
- (b) University of Wisconsin Foundation, a gift from Brook Hill Farms, Inc., Chicago, Illinois, one stainless steel soft-kurd tank and fittings, and one Viking 1½ inch sanitary pump with variable speed control and motor, valued at \$1,000 for the Food Technology Laboratory in Babcock Hall at the University of Wisconsin. This gift is to be considered as a contribution raised by the Food Technology Committee of the Wisconsin Cannery Association, which has been conducting a campaign to secure special equipment for Babcock Hall.

- (i) 2,000.00 - The Visking Corporation, Chicago, Illinois, in support of a fellowship in the Department of Chemistry during the period July 1, 1951 through June 30, 1952. \$1,500.00 of the fellowship is to be given to the student in equal amounts over a twelve months period. The balance is to be used to cover the cost of fees, laboratory equipment, etc. It is anticipated that the fellowship will be placed in Chemistry and Chemical Engineering in alternate years. - (j) 10.00 - Mrs. Mary K. Heibel, Madison, Wisconsin, in memory of Elsie Karberg. To be added to the Cancer Fund for research in the Medical School. (Fund 15-327)
- (k) Mrs. Helene Stratman-Thomas Blotz, Madison, Wisconsin, a gift of a choice selection of texts dealing with Malaria to be placed in the Medical School Library. The books are from the library of the late Dr. Warren Kidwell Stratman-Thomas, a graduate of the University of Wisconsin Medical School.

- (l) \$ 756.25 - Wisconsin Association of Real Estate Brokers, Milwaukee, Wisconsin, to be added to the Paul E. - (m) 250.00 - University of Wisconsin Foundation to be added to the William S. Kies Scholarship in Finance in the School of Commerce. (Fund 15-842)
- (n) 400.00 - The Active Committee of the Philo M. Buck Memorial Scholarship Fund, to establish a Philo M. Buck Memorial Scholarship for the 1951-52 academic year. This scholarship is to be awarded for a graduate study in the Department of Comparative Literature of the University of Wisconsin, to a graduate student who has demonstrated broad, creative, and philosophic interest in world literature, and shows promise of making a contribution to the field of humane letters in the tradition developed by the late Philo M. Buck. The student to receive the award will be selected by the Department of Comparative Literature from nominations made by the Active Committee and the selection will be confirmed by the Dean of the Graduate School. Payment of the scholarship to the scholar is to be made in two installments, one-half at the beginning of each semester of the 1951-52 academic year. (Fund 15-29)

- (o) 1,131.03 - The George C. Allez Memorial Fund Committee, as the initial contribution for the establishment of the George C. Allez Memorial Fund, to perpetuate the memory of the Late George C. Allez, Director of the University of Wisconsin Library School, and to be used for the purchase of books and related teaching materials for the University of Wisconsin Library School as may be determined by the Director of the University of Wisconsin Library School. Both the principal and interest of this fund, which is to be maintained as a University Trust Fund, shall be available at the discretion of the Director of the University of Wisconsin Library School for purchases. - (p) 2,800.00 - The Oaklawn Foundation, New York City, to establish the William S. Kies Scholarships at the University

of Wisconsin. This gift is to be renewed annually to award eight scholarships of \$350.00 each to students selected in accordance with the following conditions of award:

- 1) Scholarships may be granted to any United States citizen who resides in and whose legal residence is within the continental limits of the United States.
- 2) Scholarships shall be awarded so that over a period of six years and thereafter, the ratio shall be at the rate of two men to one woman.
- 3) No special course of study shall be deemed a necessary qualification for the scholarships.
- 4) Students selected shall possess outstanding qualities of citizenship and leadership, shall have attained high scholastic standing, and shall have a real need for financial assistance.
- 5) The scholarships shall be awarded to qualified students for the full four years of the University's undergraduate course, with eight scholarships to be awarded initially to two students in each of the four undergraduate classes, and with two scholarships to be awarded annually thereafter to freshmen.
- 6) Any unused scholarships, due to a student completing a four-year course in three, or dropping out of college, shall be awarded to another qualified student within the same year of study.
- 7) The administration of the scholarship will be controlled by general scholarship rules of the Regents administered by the Committee on Loans and Undergraduate Scholarships. (Fund 15-30)

- (aa) 60.00 - From Friends of the late Dean F. E. Turneaure for the establishment of the Dean F. E. Turneaure, College of Engineering, Loan Fund. This gift is to be administered as a trust fund with income and additional contributions to be added to the principal until the principal amounts to at least \$100.00, at which time the total fund is to be transferred to the Student Loan Fund account. Loans are to be made to students without interest while they are enrolled in the College of Engineering. Upon motion of Regent Werner, seconded by Regent Kleczka, action No. 2 (a) to (f), inclusive, listed under the recommendation and report of the Vice President of Business and Finance (I. Report of Actions Taken) was approved.

II. Miscellaneous

1. That Mr. Bernard F. Hess be deputized as a University Police Officer and that the police powers authorized, September 30, 1950, for Mr. Harold T. Gassen be cancelled.

Upon motion of Regent Gelatt, seconded by Regent Campbell, recommendation No. 1 listed under the recommendation and report of the Vice President of Business and Finance (II. Miscellaneous) was adopted.

Regent Gelatt reported that the Educational Committee met on May 11, 1951, and gave consideration to a number of matters, most of which are included in the Report of the President at this meeting.

Regent Jones presented the report of the Business and Finance Committee.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the following delegation of authority to the Trust Officer be approved:

(Cont.)

- a. The Trust Officer shall be responsible for the active management and administration of University Trust Funds under the general supervision of the Business and Finance Committee.
- b. The Trust Officer may employ investment counsel with the approval of the Business and Finance Committee.
- c. The Trust Officer is authorized and empowered to purchase securities and to invest Trust Funds, within the limitations imposed by State Statutes and by the policies of the Regents as follows:
 - (1) First mortgage real estate loans on improved real estate in Wisconsin not exceeding \$25,000 for any one loan, at annual interest rates of not less than $3\frac{1}{2}\%$ net, and for periods of not to exceed 15 years. Loans in excess of \$25,000 or for less than $3\frac{1}{2}\%$ annual interest, or for periods of more than 15 years shall be submitted to the Business and Finance Committee for prior approval.
 - (2) Bonds and other non-equity securities which qualify for trust fund investments in the opinion of the Attorney General, provided that not more than 5% of the total assets of the combined trust funds shall be invested in the non-equity securities of any one issuer, excluding United States Government securities.
 - (3) Equities (common and preferred stocks) within the limits of approved lists and quotas established by the Business and Finance Committee.
 - (4) Such other securities and investments as the Business and Finance Committee may authorize from time to time.
- d. No securities shall be sold or otherwise disposed of except by specific authority and direction of the Business and Finance Committee, unless such securities are called or matured.
- e. The Trust Officer is authorized to transfer individual securities and other investments between funds within the limits established by the Business and Finance Committee as between equities and non-equities for each fund.
- f. The Trust Officer shall present a written report to the Business and Finance Committee at least once a month, or as frequently as the Committee may otherwise require, showing the details of all purchases, sales and inter-fund transfers of securities since the previous report.

(Cont.)

- g. The Trust Officer shall prepare an annual report for distribution to the Board of Regents showing the status of each fund in the University Trust Funds as of June 30, and a description of all investments. Special reports shall be prepared from time to time as directed by the Business and Finance Committee.

Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That, because of the realization of a larger amount of proceeds than anticipated from the sale of the common stocks accepted by the Regents on December 9, 1950, as a gift from Mrs. Elsie Bullard Morrison for the establishment of a second scholarship in the School of Journalism and for the establishment of a prize fund in the School of Journalism, the following revisions in the use to be made of said proceeds for the scholarship and prize funds accepted by the Regents on December 9, 1950, and the first scholarship fund accepted by the Regents on December 17, 1949, be approved:

1. The maximum amount of the scholarship to be awarded annually from each of the two scholarship funds shall be \$250.
2. From the proceeds of the sale of the common stocks \$100 shall be used for the payment of the prize to be awarded in connection with the 1951 Commencement.
3. The balance of the proceeds of the sale of, and income from, the common stocks shall be credited to the principal of the prize fund and the annual income from the prize fund in excess of the \$100 required for the annual prize shall annually be credited in equal amounts to the principal of the two scholarship funds until the principal of these funds reaches an amount that may reasonably be expected to produce an annual income of \$250 for each of the scholarship funds; and thereafter the excess annual income from the prize fund shall be accumulated as the principal of a third scholarship fund in the School of Journalism with the understanding that the scholarships from this third scholarship fund will not be awarded until sufficient funds have accumulated in the principal account to provide an income of at least \$150 a year.

Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That the Regents accept the offer of the Viking Air Conditioning Corporation, Cleveland, Ohio, to purchase from the Regents and from Mrs. Audrey M. Reid for a total cash consideration of \$6,400 the following described property:

The Southwest one-quarter (SW $\frac{1}{4}$) of Section Twenty (20) and the Northwest one-quarter (NW $\frac{1}{4}$) of Section Twenty-Nine (29), Township Forty-Five (45) North, Range Twelve (12) West, in Douglas County, Wisconsin, consisting in the aggregate of approximately 320 acres,

and that upon signature of the instrument of conveyance by Mrs. Audrey M. Reid who owns an undivided one-half interest in the property, the President and the Secretary of the Regents be authorized and they are hereby authorized to execute the instrument of conveyance in behalf of the Regents of the University of Wisconsin.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the following budget for Pre-Induction Scholarships in a program of "General, Liberal Education in the Face of the National Emergency" financed by a grant of \$279,000.00 from the Ford Foundation be approved:

and that the \$75,000.00 budgeted for 1950-51 and 1951-52 be credited to No. 15-24 Gifts and that \$204,000 be credited to the Consolidated University Trust Fund.

Upon motion of Regent Jones, seconded by Regent Campbell, it was VOTED, subject to the approval of 378,A by the Governor, that the salaries of University faculty and employees be increased effective May 1, 1951, in accordance with the provisions of Bill 378,A. (Confirming approval by mail.)

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That, upon recommendation of the Upham Woods Committee, the authorization approved by the Regents on July 15, 1950, for the construction of buildings for use of groups using Upham Woods and the allotment of funds, in the amount of \$2875 for that purpose, be rescinded, and that, upon recommendation of

the Upham Woods Committee, authority be granted for the construction of a cabin to accommodate sixteen persons on the Upham Woods property, in accordance with the plans submitted, at an estimated cost of \$5125 to be charged to the University Gift Fund 15-690, "Upham Woods 4-H Building Fund", and to cover contract costs of \$5000 and \$125 for the cost of miscellaneous items and performance bond; that the contract for this work be awarded to the White Construction Company, Wisconsin Dells, Wisconsin, in the amount of their bid of \$5000, and that the Vice President of Business and Finance be authorized to sign the contract.

(Confirming approval by mail by the Executive Committee.)

Upon motion of Regent Jones, seconded by Regent Gelatt, it was VOTED, That the President of the University and the Vice President of Business and Finance be authorized to make budget transfers and adjustments within the totals of the approved 1950-51 budget necessary to complete the business of the University for the fiscal year ending June 30, 1951.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the bequest by the late Maude Maxwell Munroe of the City of Baraboo, Sauk County, Wisconsin, to the University of Wisconsin be accepted by The Regents of the University of Wisconsin in accordance with the terms and conditions of the Last Will and Testament of Maude Maxwell Munroe, deceased; and that the President, the Secretary or the Assistant Secretary be authorized to sign receipts in the name of the Regents for the funds received under this bequest, or to do all things necessary to effect the transfer of this bequest to the Regents.

Regent Jones made the following statement regarding the bequest by the late Miss Maude Munroe:

"Miss Munroe was an alumna of the University of Wisconsin, as I believe her mother was also, and both mother and daughter gave evidence of a very sincere, genuine and persistent interest in the affairs of the University for a number of years. Miss Munroe was a member of the Board of Visitors, attended all meetings, and displayed a very active and constructive interest in the affairs of this institution."

Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That the following recommendations of the Director of Residence Halls and the Residence Halls Committee be approved pursuant to authority granted by Chapter 68, Laws of 1951:

(Cont.)

- a. That a quota of space not to exceed 2% of the total capacity of the women's halls be made available for assignment to students (undergraduate, graduate, or special) from countries and territories outside of the continental limits of the United States. (It is understood that this quota is not intended to be a limiting quota, should more space be available after satisfying demands of Wisconsin students.)
- b. That a quota of space not to exceed 5% of the total capacity of the men's halls be made available for assignments to students (undergraduate, graduate, or special) from countries and territories outside of the continental limits of the United States. (It is understood that this quota is not intended to be a limiting quota, should more space be available after satisfying demands of Wisconsin students.)
- c. That the Director of Residence Halls with the approval of the executive chairmen of the Residence Halls Faculty Committees (Dr. Little, Dean Troxell, Dean Zillman, and Lee Burns, ex officio) may make assignments to any students whose personal circumstances warrant special assignment consideration, provided that such exceptions do not exceed 1% of the halls capacity. (Such assignments would have to fall within the established class quotas for new students.)

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the following recommendations of the Director of Residence Halls and the Residence Halls Faculty Committee, relative to the men's and women's halls quotas for 1951-52, be approved:

- a. That the quotas for the women's halls for the year 1951-52 be approved as follows:

Freshmen	32%
Sophomores	28% (25% returning, 3% new)
Juniors	22% (20% returning, 2% new)
Seniors	16% (15% returning, 1% new)
Foreign students	2% (undergraduate or graduate)

In the event that applications from foreign students are not sufficient to use the quota, remaining space will be assigned to freshmen.

- b. That the Director of Residence Halls be permitted to approve assignments to Wisconsin graduate students in the men's halls for the academic year 1951-52, in order to maintain as full occupancy as possible. The policy will continue, however, to place the emphasis on assignments to undergraduate students.

(Cont.)

- c. That because of the unusual draft and manpower situation, class quotas for assignment in the men's halls be suspended for the school year 1951-52. (The policy of keeping as much as possible a balance of freshmen, sophomores, juniors, and seniors (and now also of graduates) in each house will continue.)

Book Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That, upon recommendation of the University of Wisconsin Dames Club, the terms of the Mabel Tatum Memorial Fund for student loans accepted by the Regents on October 26, 1940, be revised to provide for the granting of loans to members of Wisconsin Dames, worthy and needy graduate students, or the husband or children of a Wisconsin Dame.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the Vice President of Business and Finance be authorized to sign a renewal of the lease with the Trustees of the University Co-operative Company for the Co-op property located at Lake and State Streets on the following terms and conditions:

1. The period of the lease to be twenty years from July 1, 1956, subject to termination by the University at any time by giving two years written notice.

(Cont.)

2. That the entire responsibility for the maintenance and operation of the leased building including repairs and insurance will be paid by the University Co-op; that the University Co-op shall have the privilege of making alterations or modifications in the building or of adding improvements thereto, providing that as to improvements and structural alterations the prior consent of the University shall be obtained in writing.
3. In the event that the lease should be terminated by the University under the clause specified above, the University would reimburse the Co-op for the unamortized cost of improvements made by it as of the date of termination, it being contemplated that every improvement should be amortized over the term of the extension.
4. That the Co-op be permitted to sublease portions of the leased premises, but only with the approval and consent as to tenant by the University. It is understood that portions of the store are presently leased to Charles W. Anderes and the Kessenich Corporation, and the lease would provide for the approval of such tenants.
5. Effective with the fiscal year beginning July 1, 1956, the University Co-op shall pay rent to the University computed annually at $2\frac{1}{2}\%$ of the net gross sales made in the entire store building, with a minimum guarantee of \$12,000 per year.
6. The lease is to contain other usual and customary provisions found in similar leases, and a clause providing for renegotiation of the terms of the lease upon request of either party.

--

Regent Jones, Chairman of the Special Regent Committee appointed to prepare a recommendation for a plaque for the Memorial Library, recited the facts regarding the appropriation of funds by the State of Wisconsin for a University library and moved that the following inscription for a plaque for the Memorial Library be approved:

MEMORIAL LIBRARY

This building is dedicated as the University of Wisconsin Memorial Library to honor the men and women who served in the armed forces of the United States in the Second World War.

Many men of vision and of devotion to the University have contributed to the realization of this memorial. The citizens of Wisconsin, represented by the 1945 and 1949 Legislatures, and by Governors Walter S. Goodland and

Oscar Rennebohm, provided the public funds for the creation of this great study and research center at the beginning of the second century of the University of Wisconsin.

Regent Renk inquired regarding the proposed purchase of the Thompson Farms by the Department of Public Welfare pursuant to a bill introduced in the Legislature to appropriate \$90,000 to the Department of Public Welfare for that purpose. The Vice President of Business and Finance reported as to the leasing of the Thompson Farms (which are owned by the University in the Torger G. Thompson Estate Trust Fund for the support of the Department of Scandinavian Languages) and stated that the proposed purchase would be in accordance with the option contained in the lease between the Regents and the Department of Public Welfare.

--

Regent Laird inquired as to who speaks for the University Regents. She stated that she objected to reports in the newspapers indicating that the University Regents are opposed to, or are in favor of, a particular matter when, in fact, some of the Regents might not agree with such viewpoints. It was pointed out that a newspaper report as to Regents favoring or opposing a particular matter would indicate that that was the position of the majority of the Regents. Regent Laird stated that the papers should report the attitude of the Regents as being that of "some of the Regents" or of the "majority of the Regents."
