SPECIAL MEETING OF THE BOARD OF REGENTS

Milwaukee, Wisconsin

Thursday, July 25, 1946, 10 A.M.

Held in Mr. Cleary's Office

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Hodgkins, Jones, Kleczka, Sensenbrenner, Werner.

ABSENT: Regent Holmes.

Upon motion of Regent Grady, seconded by Regent Cleary, it was VOTED, That the minutes of the adjourned meeting of the Board held on June 23, 1946, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Appointments -

1. That Harold A. Peterson be appointed professor of electrical engineering from September 1, 1946 to June 30, 1947; salary at the rate of \$550 a month; charge to item for "professor", \$7000, electrical engineering budget for 1946-47.

Upon motion of Regent Cleary, seconded by Regent Werner, recommendation 1 listed under Appointments was adopted.

2. That the contract between the Regents of the University of Wisconsin and professor F. B. Hadley be renewed to cover the first semester of 1946-47; salary for the semester \$2375; charge to item for "Professor", \$4750, agricultural administration, p. 82.

Upon motion of Regent Werner, seconded by Regent Callahan, recommendation 2 listed under Appointments was adopted.

3. That Roger L. Corbeille be appointed research assistant in soils to do chemical work in the study of pulpwood quality as related to soil for the period

July 10 to September 15, 1946; salary for the period \$298.36; charge to Regents Unassigned - R. (The University will be reimbursed by the Wisconsin Conservation Department.)

Upon motion of Regent Cleary, seconded by Regent Callahan, recommendation No. 3 listed under Appointments was adopted.

4. That Delmar Karlen be appointed assistant professor of law for the academic year 1946-47; salary \$4250 for the year; provided in the 1946-47 budget.

Upon motion of Regent Callahan, seconded by Regent Kleczka, recommendation No. 4 listed under Appointments was adopted.

- Salary and Service Adjustments -

1. That Charles L. Fluke, professor of economic entomology, be appointed to check effects of DDT application by airplane and other methods in control of forest insects, during the period July 15 to August 3, 1946; salary \$375 for the period; charge to Regents Unassigned - R. (The University will be reimbursed by the Wisconsin Conservation Department.)

Upon motion of Regent Cleary, seconded by Regent Callahan, recommendation No. 1 listed under Salary and Service Adjustments was adopted.

2. That Llewellyn R. Cole, professor of clinical medicine, be transferred to the position of co-ordinator of graduate medical education for the year 1946-47; salary \$5200 per annum, twelve months' basis; provided in the 1946-47 budget.

Upon motion of Regent Kleczka, seconded by Regent Werner, recommendation No. 2 listed under Salary and Service Adjustments was adopted.

- Leaves of Absence -

1. That John C. Stedman, professor of law, be granted leave of absence, without pay, for the first semester of 1946-47.

Upon motion of Regent Cleary, seconded by Regent Grady, recommendation No. 1 listed under Leaves of Absence was adopted.

- Promotions -

1. That Charles F. Edson, Jr., be promoted from assistant professor of history to associate professor of history, beginning with the academic year 1946-47. (To correct an error in the budget.)

Upon motion of Regent Grady, seconded by Regent Kleczka, recommendation No. 1 listed under Promotions was adopted.

Upon motion of Regent Grady, seconded by Regent Cleary, recommendation No. 1 listed under Gifts and Grants was adopted.

2. That the following gifts and grants be accepted and the Director of Business and Finance be authorized to sign the agreements:

- (a) \$ 550.00 - The Wisconsin Bankers Association, to be credited to the research fund of the School of Commerce for the use of the Bureau of Business Research and Service.
- (b) 2,500.00 - from the Directors of the Connor Lumber and Land Company, as a memorial to the late Mr. William D. Connor and his wife, Mary B. Connor, whose home was in Marshfield, Wisconsin, the fund to be used in research for the prevention of cancer.
- (c) 7,500.00 - The Rockefeller Foundation, New York City, to permit the association of Mr. Coleman Woodbury, who will assist Professor R. U. Ratcliff with the program on housing research, for the period of one year beginning approximately July 1, 1946.

- (d) \$4,400.00 - The Rockefeller Foundation, New York City, for a grant to study the 20th Century American Negro literature, under the direction of the Graduate School, for the period July 1, 1946 to June 30, 1947.
- (e) 2,000.00 - Eli Lilly and Company, Indianapolis, Indiana, for the establishment of an industrial fellowship in the department of veterinary science to study trichomonas foetus in laboratory animals, the grant to run for a twelve months' period beginning September 15, 1946. *On file*
- (f) 1,700.00 - American Potash Institute, Inc., Washington, D.C., for the continuation, until July 1, 1947, of an industrial research fellowship in the departments of soils and plant pathology to study the use of boron as a fertilizer. *On file*

- (i) 6,810.00 - Dow Chemical Company, Midland, Michigan, for the establishment of an industrial fellowship in the departments of biochemistry, economic entomology and plant pathology; to study the effect of plant hormones and insect products on plant tissue metabolism, for a three year period, beginning June 1, 1946. *On file* X
- (j) 100.00 - Rock County Farm Bureau for the establishment of a freshman scholarship in home economics for the academic year 1946-47. *On file*
- (k) 102.50 - American Cancer Society, Beaver Dam, Wisconsin, donated by Mrs. Emma Turnell in memory of her nephew, Harold Ray, to be credited to the cancer research fund of the University of Wisconsin.
- (l) Allis-Chalmers Manufacturing Company, Milwaukee, Wisconsin, gift of equipment for research in the field of temperature measurements in combustion chambers to the Department of Mechanical Engineering.

ACTIONS BY THE PRESIDENT
Since the June 28, 1946, Meeting
of the Board of Regents

Upon motion of Regent Cleary, seconded by Regent Werner, it was VOTED, That resignations numbered 1 to 46, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was VOTED, That appointments numbered 1 to 201, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Werner, it was VOTED, That salary and service adjustments numbered 1 to 37, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was VOTED, That leaves of absence numbered 1 and 2, listed under Actions by the President, be approved.

The above actions by the President taken since the June 28, 1946, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

Upon recommendation of President Fred, and upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That the appointment of Harry Partch as project associate in the Graduate School for a period of one year, beginning July 1, 1946, be approved at a salary of \$2400 for the year and with a supplies and expense allowance of \$600; total cost of \$3000 to be charged to the income of the Anonymous Trust Fund. This appointment is subject to the understanding that the University retains the patent rights to any inventions made by Mr. Partch during the period of this appointment.

Upon recommendation of President Fred, and upon motion of Regent Grady, seconded by Regent Cleary, it was

VOTED, That the President be authorized to sign a renewal agreement for the period July 1, 1946 to June 30, 1947, for the services of Dr. R. G. Herb as expert consultant to the University of California in connection with their subcontract with the United States Government on research conducted at Los Alamos, New Mexico, and that the President also be authorized to sign a similar contract for the services of Dr. Gregory Breit to serve in the same capacity.

Upon recommendation of President Fred, and upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That the following statement in the catalog relating to the basic military science requirement be approved:

Military Science Requirement. All male freshmen and sophomores are required to enroll in military science at the time of registration with the provision that the following groups of students will be exempt: (a) students who do not meet the established physical requirements for military science as certified by the Student Health Department, (b) students who qualify and are accepted for membership in the band, (c) students who have served three months or more in the armed forces, (d) students who for other reasons are exempt or excluded by the Department of Military Science, and (e) students who complete four semesters of Naval Science will be regarded as having satisfied this requirement. (Underlined statement indicates change from previous regulation.)

President Fred distributed copies of a letter from Dean Mark H. Ingraham in which Dean Ingraham requests that his salary for the fiscal year 1946-47 be reduced from the budgeted salary of \$10,000 to a total of \$9,400 for the year. Upon motion of Regent Grady, seconded by Regent Campbell, Dean Ingraham's request was approved. Regent Callahan voted "No". (Copy of Dean Ingraham's letter on file.)

President Fred reported that Dean Elwell had requested that a committee of the Regents be appointed to discuss the future operation of the School of Banking with members of the faculty and representatives of the several bankers' associations. Upon motion of Regent Campbell, seconded by Regent Callahan, it was VOTED that this matter be referred to the Committee on Education.

President Fred referred to a number of discussions with members of the Board of Regents regarding the Law School and stated that some of the Regents had suggested the desirability of having a committee of the Regents confer with the Dean of the Law School regarding the operations of the school. Upon motion of Regent Cleary, seconded by Regent Werner, it was

VOTED, That the President of the Board appoint a special committee to confer with the Dean of the Law School regarding Law School problems. President Sensenbrenner appointed the following Regents to serve as a committee for this purpose:

Regent Grady, Chairman; Regent Holmes, Regent Werner.

Upon recommendation of President Fred, and upon motion of Regent Grady, seconded by Regent Kleczka, it was

VOTED, That Dr. Conrad A. Elvehjem be appointed Dean of the Graduate School on a part-time basis for one year, effective August 1, 1946, without change in his present salary of \$9400, on the twelve months' basis; salary to be distributed one-half to the College of Agriculture and one-half to the budget of the Graduate School. (It is understood that Associate Dean Herriott will continue on a part-time basis as heretofore and that an additional assistant or associate dean will be appointed to help with the administrative work in the Graduate School. It

is understood also that Dr. Elvehjem will continue to serve as Chairman of the Department of Biochemistry in the College of Agriculture and that he will be Chairman of the Research Committee.)

Upon motion of Regent Grady, seconded by Regent Campbell, it was VOTED, That Section 2 of Chapter I of the Regents' By-Laws relating to the dates of regular meetings of the Board be amended to provide that regular meetings shall be held on the Thursday following the second Wednesday in each month, except in the month in which the annual meeting is held, when the regular meeting shall be the date specified in Section 1 of Chapter I for the annual meeting, and that Section 1 of Chapter I of the Regents' By-Laws be amended to provide that the annual meeting shall be held, unless otherwise specially ordered, on the day before the annual Commencement. (A copy of Sections 1 and 2 of Chapter I of the By-Laws, as revised, is attached to these minutes.)

Upon motion of Regent Cleary, seconded by Regent Kleczka, it was VOTED, That the area of land on the East Hill Farm between Midvale Boulevard extended and Meadow Lane be used as the site for the trailer camp for personally-owned trailers and that any details relating to this project which will require further approval be referred to the Constructional Development Committee with power to act.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Callahan, seconded by Regent Kleczka, it was VOTED, That an appropriation of \$12,000 be made from unbudgeted 1-E balances to pay the cost of conducting a nursery school in conjunction with the School of Education at the Badger Village Veterans' Housing Development.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Jones, seconded by Regent Grady, it was VOTED, That the charges for bus transportation between the campus and the Badger Village Veterans' Housing Development be established at ten cents for one-way fare for students and University employees, and that an allotment of not to exceed \$50,000 be made from unbudgeted 1-E balances to pay the cost of transportation service not recovered from fares collected.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Cleary, seconded by Regent Kleczka, it was VOTED, That an appropriation of \$2700 be made from unbudgeted balances in 1-E for the purpose of continuing library, nursing and auxiliary services at the Badger Village Veterans' Housing Development.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Werner, seconded by Regent Callahan, it was VOTED, That the following appropriations be made from unbudgeted 1-E balances for the purposes stated:

- (a) Initial appropriation for remodelling a part of the first floor and basement of the University Y.M.C.A. building for classroom and other University purposes \$10,000
- (b) Equipment for temporary classroom and laboratories 8,600
- (c) Construction of nuclear physics laboratory addition to Sterling Hall (Transfer to 20.41(11)) 50,000.

Regent Grady discussed the status of the Hammersley case which was referred to the Committee on Welfare and Student Life at the conference meeting of the Regents held on May 3, 1946, and suggested that the matter be referred to the Personnel Committee. No action was taken.

The Director of Business and Finance presented two resolutions adopted on July 18, 1946, by Wisconsin General Hospital Local #134 and University of Wisconsin Employees Local #171 relating to the establishment of a 38½ hour work-week and to a 30% emergency increase in salaries of University civil service personnel. (Copies of resolutions attached.) He also reported that studies made by the Bureau of Personnel indicate that salary increases in the classified service are reported to be 16.2% lower than the increase in the cost of living. It was explained that the Regents are authorized to approve increases in civil service salaries on July 1 of each year, in accordance with the salary and step-increase schedules specified by the State Statutes, and that all increases at times other than July 1 require the approval of the State Personnel Board and the State Emergency Board. The Director stated that a committee has been appointed by the State Director of Personnel to study the suggestion that the State adopt a 40-hour, five-day week. It was the consensus of the Regents that there should be an opportunity to review the findings of the committee before any action is taken on establishing a reduced work week. Upon motion of Regent Callahan, seconded by Regent Cleary, it was

VOTED, That the Governor, the State Emergency Board, and the State Personnel Board be requested to take such action as is necessary to increase civil service salaries immediately to meet the increases in the cost of living of University civil service employees, and that the Emergency Board be requested to provide the funds needed for this purpose.

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That the Bureau of Personnel be requested to comply with the provisions of 16.105 of the Wisconsin Statutes regarding proposed changes in the salary ranges of employees in the classified service, and that the recommendations of the Bureau of Personnel for salary schedules to be submitted to the Joint Committee on Finance be submitted to employing departments for their review and consideration before they are placed in final form for presentation to the Joint Committee on Finance.

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

1. That the Director of Business and Finance be authorized to sign a co-operative agreement between the U.S. Geological Survey and the State Geologist of Wisconsin for topographic surveys; with the understanding that each party to the agreement will make available \$15,000 for the fiscal year July 1, 1946, to June 30, 1947, the University appropriation to be charged to 20.41 (17a). *On file*
Adopted.

2. That the Director of Business and Finance be authorized to sign a lease agreement with the University of Wisconsin Y.M.C.A. for the use of approximately 7,130 square feet of space in the Y.M.C.A. building located at 740 Langdon Street for a period of three years beginning September 1, 1946, and ending August 31, 1949, at an annual rental of \$5,880.
Adopted.

3. That the Director of Business and Finance be authorized to sign a memorandum of agreement with the Wisconsin Conservation Department regarding the Wisconsin Fish Collection for the period July 1, 1946 to July 1, 1948.
Adopted.

II. Trust Funds

1. That the action of the Regents on January 19, 1946, which provides

"That the person who holds the office of Secretary of the Board of Regents and Trust Officer be authorized to sign proxies in behalf of the Regents on common and preferred stocks held in any University funds" be amended to read as follows:

"That proxies in behalf of the Regents on common and preferred stocks held in any University funds shall be signed by either the Trust Officer or the Secretary of the Board of Regents."

Adopted.

III. Miscellaneous

1. That the action of the Wisconsin University Building Corporation in purchasing the west half of the south half of Lot 10, Block 2, University Addition to the City of Madison, Dane County, Wisconsin; from Clayton R. Scott and Leona A. Scott, his wife, for a consideration of \$13,500 be approved.

Adopted.

Upon motion of Regent Cleary, seconded by Regent Kleczka, the recommendations of the Director of Business and Finance were adopted.

Budget ✓
The Director of Business and Finance called attention to a provision in the old by-laws of the Regents requiring that each requisition involving an expenditure in excess of \$200 shall be signed by the Chairman of the Executive Committee and that this practice had been continued since the adoption of the new by-laws. Regent Cleary, Chairman of the Executive Committee, stated that he thought this procedure was unnecessary and upon motion of Regent Grady, seconded by Regent Werner, it was

VOTED, That all requisitions, regardless of amount, be approved by the Director of Business and Finance or his designated subordinate without further approval by the Chairman of the Executive Committee.

The Director of Business and Finance reported that in accordance with authority granted by the Regents he has signed applications to the Civilian Production Administration for permission to build the following structures:

- (a) Quonset hut for temporary library, signed July 16.
- (b) Quonset huts for temporary classrooms, signed July 18.
- (c) Quonset huts for temporary chemical engineering laboratories, signed July 23.

The Director of Business and Finance distributed copies of a report on the use of classroom space. (Copy on file.)

The Regents recessed for luncheon at 12:15 P.M.
and reconvened at 1 P.M.

President Fred distributed reports showing the critical need for housing accommodations for members of the faculty as well as for students attending the University. The Director of Business and Finance read a report of the conference held on July 19, 1946, in the President's Office, regarding the housing situation and a proposed construction program. At that conference representatives of the Wisconsin Alumni Research Foundation proposed to the Regents that the Foundation be permitted to build multiple-family housing units on University land for graduate students, junior staff and other faculty. The Wisconsin Alumni Research Foundation is proposing to invest a maximum of \$2,000,000 in this project. (Copy of report on file.) Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the Wisconsin Alumni Research Foundation be advised that the Regents approve their proposal for a housing project to be located on the Eagle Heights Farm in an area of approximately ten to twelve acres between the University orchard and the Village of Shorewood Hills on the following terms and conditions:

- (1) That the rate of interest on unpaid balances be 1%.
- (2) That the principal amount be amortized at the rate of 2% annually for fifty years.

- (3) That there be no personal liability on the part of the Regents or the Wisconsin University Building Corporation, and that the only recourse in the case of default would be that the Wisconsin Alumni Research Foundation would take over the buildings subject to the leasehold.

At the conference on July 19, 1946, consideration also was given to the proposed construction of apartments for married veterans and additions to the men's dormitories. It was reported that these projects could be constructed simultaneously with the W.A.R.F. housing project. Upon motion of Regent Kleczka, seconded by Regent Jones, it was

VOTED, That the action of the Wisconsin University Building Corporation in sending a letter of intent to the George A. Fuller Company of New York relating to the construction of the married veterans' apartment buildings; at a cost of approximately \$800,000, and an addition to the men's dormitories, at a cost of \$525,000, be approved. (Confirming informal approval given by the Regents at the conference on July 19.)

Upon motion of Regent Cleary, seconded by Regent Werner, it was

VOTED, That the Wisconsin University Building Corporation be authorized to enter into a contract or contracts with the George A. Fuller Company of New York on a cost plus-fixed fee basis for the construction of the married veterans' apartment buildings, consisting of 120 apartment units, and the addition to the men's dormitories for approximately 200 single men.

Upon motion of Regent Kleczka, seconded by Regent Callahan, it was

VOTED, That the Estate of William H. Varnum, deceased, be paid a total of \$2450; charge to Summer Session Trust Account. (Charge \$1191 to principal on account of deposits made by Professor Varnum for teaching in the 1927 and 1938 summer sessions and the balance charge to Summer Session Trust Fund income.)

President Fred distributed photostatic copies of a letter of appreciation to the Regents from persons who attended the Fourth Annual Institute for Church Leaders conducted by the School for Workers. (Copy on file.)

Upon motion of Regent Kleczka, seconded by Regent Jones, it was

VOTED, That A. W. Peterson be appointed to act as liaison officer between the Wisconsin Alumni Research Foundation and the University in connection with the proposed Wisconsin Alumni Research Foundation project.

President Fred distributed a report of the Student Counseling Center.
(Copy on file.)

BY-LAWS OF THE BOARD OF REGENTS

CHAPTER I

Meetings and Business of the Regents

Annual Meetings

Section 1. The annual meetings of the Regents of the University of Wisconsin shall be held, unless otherwise specially ordered, on the day before the annual Commencement.

Regular Meetings

Section 2. Regular meetings shall be held on the Thursday following the second Wednesday in each month, except in the month in which the annual meeting is held, when the regular meeting shall be the date specified in Section 1 of Chapter I for the annual meeting.

RESOLUTION
Relating to 38½ Hour Work Week

- Whereas, university civil service employees are working weekly schedules varying from 38½ to 48 hours, and
- Whereas, there is a general trend throughout the country in public and private employment toward a maximum 40 hour - 5 day work week, and
- Whereas, many public and private employers have salary schedules pegged to the 40 hour week thus making comparisons between university salaries and salaries paid by outside employers difficult, and
- Whereas, the maximum 38½ hour work-week will be of benefit both to the employees and the university by lessening fatigue, helping in recruitment, creating employment opportunities for veterans, permitting better home life, reducing personnel turnover, saving light and fuel, improving the health of university workers, and in general by improving the competitive position of the university with federal service and private employment, and
- Whereas, there is great need for uniformity in working hours throughout university departments, and
- Whereas, the attorney general has ruled that the basic work-week in state service shall consist of 5½ seven hour days to be consistent with past actions of the legislature,

Now, Therefore, Be It Resolved,

That the membership of locals 134 and 171 of the Wisconsin State Employees Association and the American Federation of State, County and Municipal Employees (AFL) representing over 50 per cent of the university civil service staff hereby petition the Board of Regents of the University of Wisconsin to establish immediately a uniform maximum 38½ hour work-week for all university civil service employees, and

Be It Further Resolved,

That adequate arrangements be made to provide compensatory time off or overtime pay for all hours of emergency overtime worked by employees in excess of the maximum weekly schedule of 38½ hours.
